**Briefing for non-governmental organizations in accordance with resolution 4/6 of the Conference of the States Parties to the United Nations Convention against Corruption entitled “Non-governmental organizations and the Mechanism for the Review of Implementation of the United Nations Convention against Corruption”\****Summary*

In resolution 4/6, adopted at its fourth session, the Conference of the States Parties to the United Nations Convention against Corruption decided that briefings for non-governmental organizations would be conducted on the outcomes of the review process, including technical assistance needs identified. These briefings would be convened on the margins of the sessions of the Group and conducted by the secretariat in cooperation with a member of the bureau, at the request of the President of the Conference, on the basis of the Implementation Review Group reports, thematic implementation reports and regional supplementary addenda. A summary of the briefing will be prepared and made available on the website of the Group in the form of a conference room paper.

## **Programme for the briefing**

### **A. Introduction**

The briefing will be held on 3 September 2024 at 10 a.m. in Conference Room M-3, M-Building, Vienna International Centre. The briefing will be held in person and interpretation will be provided into all the official languages of the United Nations. Registered participants will also be able to observe the proceedings online using the Microsoft Teams platform, without the possibility of making statements.

At the start of the briefing, following an opening statement by the Chair, the secretariat will recall the terms of resolution 4/6 of the Conference.

### **B. Programme**

The briefing by the secretariat will focus on the outcomes of the review process, including on technical assistance needs identified.

The secretariat will provide an introduction to the work of the Implementation Review Group, based on the note by the Secretariat on the performance of the Mechanism for the Review of Implementation of the United Nations Convention against Corruption ([CAC/COSP/IRG/2024/3](#)), the note by the Secretariat on the updated analysis of the views of States parties on the next phase of the Mechanism for the Review of Implementation of the United Nations Convention against Corruption ([CAC/COSP/IRG/2024/9](#)) as well as the thematic report prepared by the Secretariat on the implementation of chapter II (Preventive measures) of the United Nations Convention against Corruption ([CAC/COSP/IRG/2024/11](#)) and the report prepared by the Secretariat on the implementation of chapter II (Preventive measures) of the United Nations Convention against Corruption (regional supplement) ([CAC/COSP/IRG/2024/12](#)).

The secretariat will also provide an oral update on technical assistance needs identified through the reviews and on the technical assistance provided by UNODC in support of the implementation of the Convention.

### **C. Activities and contributions to the implementation of recommendations of the Group approved by the Conference**

In its resolution 4/6, the Conference encouraged non-governmental organizations to report to it or to the Group, as appropriate, individually or collectively, on their activities and contributions to the implementation of the recommendations and conclusions of the Group approved by the Conference, including those related to meeting technical assistance needs and advancing capacity to effectively implement the Convention.

In order to facilitate the implementation of this mandate, non-governmental organizations will deliver statements, and also engage in a discussion during the briefing.
